In terms of the aforesaid Postal Ballot Notice dated 14th November, 2017, dispatched to the Shareholders of the Company on 27th November, 2017 and the Public Notice published on 'Sukhabar' and 'Business Standard' pursuant to Rule 22(3) of the Companies (Management and Administration) Rules, 2014 on 25th November, 2017, the period for Remote E-voting commenced at 09:00 A.M (IST) on Friday, 1st December, 2017 and ended at 05:00 P.M (IST) on Sunday, 31st December, 2017 for voting through E-voting and Postal Ballot forms.
